Don't worry, all the sessions will be recorded and available up to 30 days following the conference to all registered attendees. Some states are allowing more flexibility with pre-recorded credits due to the pandemic. We will do everything possible to get all pre-recorded sessions accredited with each state. We ask that you know your states requirement(s) to insure acceptance of your session(s) for CLE.

Ron is Of Counsel at Jenner & Block, LLP in Chicago, Illinois. His specialties include Bankruptcy and Restructuring, Corporate, and Real Estate and Hospitality.

Debtors, trustees, creditors, committees, landlords, and secured lenders in Chapter 11 cases turn to him for his counsel. Ron also advises clients on transactional issues such as corporate restructurings. His distinguished career has been highlighted by presiding over high-stakes complex commercial cases, including that of the country's 10th largest commodities house and a \$1.7 billion Ponzi scheme.

A fellow of the American College of Bankruptcy, Ron is a prolific lecturer and writer on bankruptcy and commercial law issues. He contributes to this area of law by his involvement in several initiatives and organizations. Ron served on the panel of the Chapter 7 Trustees for the Northern District of Illinois, Eastern Division, from 1989 to 2021. He served on the American Bankruptcy Institute's commission to reform our nation's bankruptcy laws, which submitted its report to Congress in 2014. He also was the co-chairman of the Avoidance Action Committee for the ABI's Commission on the Reform of Commercial Bankruptcy Laws. He is a member of INSOL (International Association of Restructuring, Insolvency & Bankruptcy Professionals) and, in the past, served on the board of the National Association of Bankruptcy Trustees.



# Mediating Bankruptcy Disputes: A Ghost-Runner on Second or Need a New Game?

Bankruptcy practice relies on mediation from preferences to chapter 11 plan formulation and confirmation, and many other claims and litigation disputes in a wide variety of settings, including appeals. The use and practice of mediation has generated some debate among academic and practitioner commentators, suggesting the issue is well developed for discussion.
