This panel will explore how that jurisprudence will impact plan provisions that we've come to expect as a traditional path to confirmation in chapter 11s. Regarding the releases, is an opt in or opt out sufficient for consent? Can non-voting creditors be "deemed" to have consented to such a release?

The esteemed professors who study these topics and practitioners who deal with them day-to-day will offer their perspectives on the crossroads of party-in-interest standing; non-debtor third party injunctions and nonconsensual non-debtor third party releases. Come join us for a stimulating discussion and prognostication of what awaits in the ever-changing ocean of chapter 11 practice.
